Personal Information Report from Tasmanian Collection Services

Personal Information Report can be obtained online www.tascol.com.au/PIR. If you have recently arrived in Tasmania from another state you will need to obtain a report from Veda http://www.veda.com.au/ Unfortunately we are unable to accept reports older than 30 days.



Police Check

We can photocopy your police check in office so you can keep your original document. Police Checks must be not be more than 12 months old.



Drivers licence

Your drivers licence can be photocopied at our office. If you do not have a drivers licence you may provide another form of photographic identification.



Proof of income

If you are currently employed you will need to provide copies of your two most recent payslips. If you receive a benefit from Centrelink you will need to provide a copy of your most recent income statement. For any other types of income please provide a copy of a recent bank statement.



Completed application form

The application form must be completed in full, including details for current and previous living situation and three character references. Please ensure all applicants have signed the privacy disclosure statement on the last page!

Thank you for taking the time to complete our application, we will attempt to process your application within two business days. Immediately after your application is complete and we have received the landlord's instructions you will receive an SMS notification.

Once your application has been approved you will be required to sign your lease within 24 hours, upon signing the lease you will be required to pay the first two weeks rent and full security deposit.
